



Geographic Information

The City of Lexington was established in 1778 and is located at the southern end of the Shenandoah Valley of Virginia. It was chartered as an independent city in 1966 and was listed on the National Register for Historic Places in 1972. Since its establishments, the main industry has been education. The City of Lexington is home to the Virginia Military Institute (VMI) and Washington and Lee University (W&L), which contributes to high levels of cultural activity and tourist traffic flow in the community. Other contributors include, but are not limited to, the Lime Kiln Theater, Fine Arts in Rockbridge, and the Rockbridge Historical Society, amongst numerous other community organizations. Recreational opportunities within and around the City of Lexington include the Natural Bridge State Park, Virginia Horse Center, George Washington and Jefferson National Forests, Goshen Wildlife Management Area, the Blue Ridge Parkway, and more. In a city that boasts with southern hospitality and hometown charm with a deep historical connection, there is something for everyone to love!



Police Chief's Advisory Board

The Police Chief's Advisory Board was created in 2021 to enhance the police department's engagement with the community. The board consists of 11 carefully selected community members who assist with providing input and recommendations on topics such as police-community relations, public awareness of services and programs, community policing policy initiatives, racial equity issues, use of force, mental health response, criminal activity and trends, and transparency in operations. The Advisory Board meets four (4) times per year and each member serves a two-year term. The Lexington Police Department will select 11 candidates for the second Police Chief's Advisory Board in 2024.








Major Crimes Analysis

The Lexington Police Department is one component of the budget for the City of Lexington and is based on the City's fiscal year from July 1st to June 30th.

The total police department budget for FY-24 was \$2,338,038,. Of this amount, \$2,001,924 was committed to personnel costs for salaries and benefits. The remaining \$336,114 was committed to operational costs.

Agency Activities



Accreditation

Since January 1998, the Lexington Police Department has held the prestigious status of accreditation under the auspices of the Virginia Law Enforcement Professional Standards Commission (VLEPSC). This achievement represents a milestone in the history of the Lexington Police Department as practically every employee contributes in some manner to the success that is represented in achieving agency accreditation.

State accreditation is the best measure of an agency's compliance with professional law enforcement standards, as determined by the Virginia Law Enforcement Professional Standards Commission. The Commission consists of Virginia sheriffs and police chiefs selected for their expertise and knowledge. Adherence to an acknowledged body of professional standards may help protect an agency against a variety of potential liability problems.

Compliance with the professional standards set forth by the Virginia Law Enforcement Professional Standards Commission is evaluated by a team of certified assessors on a four year cycle. Proof of compliance must be shown for all 192 applicable standards each year. The Lexington Police Department was evaluated in January of 2023. In March of 2023 the Commission granted the agency its seventh reaccreditation.



The Lexington Police Department partnered with the VA Attorney General's Office, Lexington Police Foundation, The Community Foundation, and numerous community organizations to host it's second two-week long, Jr. Police Summer Camp. This camp was open to the youth in the City of Lexington as well as within the surrounding areas, and more than doubled in participation compared to last year. Each day averaged approximately forty-two campers. Our camp focuses on fostering the development of positive relationships between the community's youth and police staff while also offering fun, educational opportunities, and lessons on healthy lifestyle choices. This year, the LPD partnered with several community organizations and services including, but not limited to: Natural Bridge State Park, Natural Bridge Zoo, Caverns at Natural Bridge, Dinosaur Kingdom II, VA Safari Park, Virginia Military Institute, Washington & Lee University, Greater Rockbridge Area Skateboarder Coalition, R/C Theater, Friends of Rockbridge Swimming, Lexington/Rockbridge Juvenile and Domestic Courts, Rockbridge Regional Emergency Communications Center, and Lexington City Schools.












Halloween Costume Contest



The Lexington Police Department held it's 5th Annual Halloween Costume Competition in October 2023. Three LPD Personnel dressed up in costumes and submitted a photo to be posted to the department Facebook page for the community to vote for their favorite. Community Walks

Community Walks were established in 2021 to create more accessibility for the community to communicate with police personnel, members of the Lexington Fire Department, and other community organizations. This gives residents an opportunity to meet those that serve them in a non-critical environment and allow them to communicate questions or concerns they may have.

Each month, the police department selects a street within the community to host a walk and invites all members of the community to attend. In 2023, the Lexington Police Department conducted 10 community walks at the following locations: High St., Myers St., Tucker St., Edmondson Ave., Chavis Ave., Summit St., Arpia St., Senseny Ln., Wills Rd., and Confederate Cir..

A Day in K

Members of the LPD and Rockbridge Sheriff's Office participated in the DEA's National Drug Take Back. This is a biannual event that provides the community with an opportunity to properly dispose of unused, expired, or unwanted medications -- no questions asked.


